FEE CHARGEABLE FOR THE PROPERTY VALUATION SERVICES

Foreword

The Institute of Real Property Valuers in Rwanda (IRPV) was established by Law N° 17/2010 of 12/05/2010 establishing and organizing the real property valuation profession in Rwanda as published in Official Gazette n° 20 of 17/05/2010. Among other responsibilities, it is mandated by the law to prepare regulations and guidelines governing the real property valuation profession.

It is in this regard that the Institute has set this Fee Structure for the purpose of regulating remuneration intended for valuation services and ensure necessary time and attention is provided for delivery of appropriate services by valuers.

The Institute is also aware of the national inclusive development agenda and has herein insured its contribution for corporate social responsibility by committing itself to providing a subsidy for valuation services that may be needed by people in the Lower Category of the population commonly known as "Icyiciro cya I cy'Ubudehe". This will give them access to valuation services free of charge facilitating to resolve problems they encounter day to day and possibly.

Definitions of terms:

- i. **Fee Structure:** Document guiding all negotiation and transactions of remuneration/payment related to valuation services.
- ii. **Registered Office:** District or City of Kigali where the valuer has registered his office during business registration.
- iii. **Subsidy:** IRPV and valuer's contribution for provision of valuation services to a citizen of Icyiciro cya I cy'Ubudehe with evidence of the need. IRPV contribution shall be a transport allowance to the valuer.
- iv. Surroundings: Districts surrounding the registered office of the valuer.
- v. Other places: Other area than the registered office of the valuer and the surroundings.
- vi. **Special property:** Properties with the nature that requires higher technical and specialized services, these properties not limited to (Mines & Quarries, Fuel Stations and Fuel Storage, Plants & Machinery, Fiber Optic Cable line, Power Transmission Line & Water Supply systems and other special facilities.

- vii. **Special Services:** Other technical/specialized services that may be required for feeding data to the valuer during an assignment of a normal nature (of a non-Special property) such as: Quantity Surveying, Land Surveying, Engineering, testing, etc
- viii. **Transport and overheads:** in kind contribution or negotiated cash payment to facilitate mobility of the valuer's team and other overheads during an assignment.
